General Clinic Information

- 1) If you are seeking **RECORD SEALING** assistance, please bring a copy of the sentencing(s) for the conviction(s) that you want to be sealed. (Here a “conviction” may include more than one crime, if they are part of the same sentencing order.) This service is limited to the 3-4 convictions that are causing you the most legal trouble. Clients who show up at clinics without their sentencing order(s) should still be placed with an attorney for legal information or assistance. The attorney should provide them with blank forms, and general instructions on how to complete those forms. **IF YOU ARE CURRENTLY ON PROBATION OR PAROLE, FACING CRIMINAL CHARGES, OR HAVE AN ACTIVE WARRANT, WE MAY NOT BE ABLE TO ASSIST YOU.**

- 2) If you are seeking **ESTATE PLANNING** assistance, please bring a copy of the deed(s) for any real property(ies) that you want to make arrangement for, and the name(s), dob(s), and address(es) of your children (living and deceased) and any other person(s) for whom you want to make arrangements; also bring any prior established Will(s) or Trust(s). **IF YOU HAVE BEEN DIAGNOSED WITH ANY FORM OF MENTAL CONDITION, SUCH AS DEMENTIA, WE MAY NOT BE ABLE TO ASSIST YOU.**

- 3) If you are seeking **HOUSING** assistance, please bring a copy of your rental/lease agreement, any legal paperwork that you may have been provided with regard to any current eviction process. **IF YOU HAVE BEEN SERVED WITH EVICTION PAPERS, PLEASE CALL OUR HELPLINE IMMEDIATELY 1-800-952-9243.**

- 4) If you are seeking **TAX** assistance, please bring any tax documents that are relevant to those issues. **IF YOU HAVE IMMEDIATE CONCERNS, PLEASE CONTACT OUR LOW-INCOME TAX CLINIC AT 1-870-732-6373.**

- 5) If you are seeking **FAMILIY LAW** assistance, such as DIVORCE, CUSTODY, VISITATION, PATERNITY, CHILD SUPPORT, GUARDIANSHIP, OR ADOPTION, please bring any documents related to any prior court cases involving the same child(ren), and if you can, please bring the child's(ren's) birth certificate. **IF YOU ARE NEEDING HELP WITH AN ORDER OF PROTECTION, PLEASE CALL OUR HELPLINE IMMEDIATELY 1-800-952-9243.**
